You are about to purchase a product that is not simple and may be difficult to understand.

1 What is this product?

This product is a derivative security issued under Irish law.

Objective

The objective of the product is to provide you with a specified entitlement according to predefined conditions. The product does not have a fixed lifetime. You may exercise the product on any Exercise Date. The Issuer has the right to terminate the product on any Exercise Date. After exercise or termination, you will receive a Redemption Amount in the Currency of the Product on the relevant Redemption Date. The Redemption Amount will correspond to the Reference Price of the Underlying on the Exercise Date multiplied by the current Multiplier.

The Issuer is entitled to terminate the product giving one month notice. In the case of any termination, the termination amount may possibly be significantly below the Issue Price. The risk indicator assumes you keep the product for five years. The actual risk

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 6 out of 7, which is a high-risk class. This rates the potential losses from future performance at a high level, and poor market conditions are very unlikely to impact our capacity to pay you. 3. What happens if iMaps ETI AG is not able to pay you?

5. How long should I hold it and can I take money out early?

Recommended holding period: 5 years

The average investor holds this kind of product for about 5 years on average. Furthermore, this period enhances the comparability with other investment products without a fixed lifetime.

You can sell the product on any trading day via the stock exchange on which the product is listed or over-the-counter at the paying agent. If you exercise or sell the product before the end of the recommended holding period, the amount you then receive may be, even significantly, less than the amount you would otherwise have received.
